Abstract

Radiant's Doug Kreysar will show you how new high-resolution measurement solutions are addressing higher pixel-densities, larger screen sizes, and limited cycle times. High resolution measurement with imaging colorimeters enables pixel-by-pixel inspection of LCD, OLED, and other displays, facilitating:

- Detailed detection of pixel, line, and particle defects
- Mura detection in high definition displays
- Pixel luminance measurements
- OLED screen correction at an individual pixel level

A detailed presentation of these, and other applications for high resolution measurement, will be accompanied by a live inspection demonstration.

As Chief Solutions Officer, Doug Kreysar heads Radiant's engineering, product development, operations, and marketing teams to ensure the successful implementation of customer solutions worldwide. Under his direction, Radiant's optical technologies for light and color measurement have become known as the gold standard for production applications. Prior to joining Radiant in 2000, Kreysar was head of the optical design group at North American Lighting, Inc. (NAL). Kreysar received a B.S. in Physics from Vanderbilt University, and an M.S. in Applied Physics from the University of Michigan, Ann Arbor. The author of multiple technical papers
